The Bowling Centers Association of Wisconsin (BCAW) will once again administer the WI Pepsi USBC Youth Championships. You will find the forms and rules (which must be read by all coaches and bowlers) at bowlwi.com. A check-off list of deadlines & other pertinent information is indicated below.

COACHES: If you are no longer actively coaching at the center, please contact the center so the proper personnel may be notified. If coaches would like any materials or information sent directly to them, please indicate your home address on the entry forms otherwise all information will be directed to the center.

PROPRIETORS: If you receive materials and are not the youth coach, please make sure that information is given to the appropriate people.

DATES & THINGS TO KNOW:

- **September 30, 2023.** All material should be given to the junior coach(s) or person running junior bowling.
- **October 14, 2023.** Update your BLS system. Make sure the divisions are correct.
- **November 4- 18, 2023.** First round of qualifying; pre/post bowling scores are not eligible for in-center qualifying. Notify bowlers/parents one week before you run qualifying and distribute copies of rules for this tournament. Bowlers that have qualified in the 1st round are given their "Certificate of Achievement" and entry form which is available at bowlwi.com.
- **December 16, 2023.** The 1st round qualifiers' in-center league worksheets, entries & monies must be submitted to the BCAW. ****DO NOT** wait to send 1st and 2nd rounds together.
 ➔ **Make sure ALL information is complete & correct including name, squad choice and birthdate.**
- **January 6- 20, 2024.** The 2nd round qualifiers; pre/post bowling scores are not eligible for in-center qualifying. Notify bowlers/parents one week before you run qualifying and distribute copies of rules for this tournament. Bowlers that have qualified in the 2nd round are given their "Certificate of Achievement" and entry form which is available at bowlwi.com.
- **February 16, 2024.** The 2nd round qualifiers' in-center league worksheets, entries, and monies **MUST BE RECEIVED** in the BCAW office. **No additional entries will be accepted after this date.**
- **April 6 & 7, April 13 & 14, 2024.** Regional tournaments held. See the regional site schedule for your specific place and times.
- **May 11, 2024.** State finals held at Revs Bowl, Bar & Grill in Oshkosh (Boys' Division) and Rolling Thunder Lanes in Neenah (Girls' Division).
- **July 12-20, 2024.** The Junior Gold Championships in Detroit, Michigan.

FEES: In U8 and U10 Boys' & Girls' Divisions the fee is **\$30 with every advancing entry.** In U12, U15 and U18 Boys' & Girls' Divisions the fee is **\$40 with every advancing entry.** This is a one-time entry fee which includes the state finals.

Send only one check from the coach or center made payable to BCAW. NO INDIVIDUAL CHECKS. There is a \$50 fee charged for any returned non-sufficient funds checks.
